## 1. Introduction

- 1.1. At REDISA we recognise and respect your right to privacy. In this policy we will explain how we will handle your personal information.
- 1.2. Please note that we do not intentionally collect any personal information about children – natural persons under the age of 18.
- 1.3. “personal information” means “personal information” as defined in the Protection of Personal Information Act 4 of 2013.

## 2. How we will collect personal information

We will collect personal information about you:

- 2.1 when you submit any personal information to us;
- 2.2 from third parties where required for our legitimate business purposes;
- 2.3 automatically through the use of cookies (a cookie is a small piece of information stored by your browser, typically used to identify returning visitors, and to collect aggregate information on the number of visitors to a site and the number of pages viewed, but you can set your browser to prevent this if you want to).

## 3. How we will use your personal information

- 3.1. We will use your personal information for our legitimate business purposes or for reasons where we obtained your consent to use it or you required us to use it.
- 3.2. If we want to use your personal information for any other reason, we will obtain your consent first.

## 4. How we will share your personal information

We will share your personal information for our legitimate business purposes or where required to do so in law. These would typically include sharing for the following purposes and may include sharing with third party service providers, agents, contractors, employees, law enforcement agencies or business affiliates:

- 4.1 Marketing;
- 4.2 Enforcement of the law;
- 4.3 Enforcement of any agreement between you and REDISA;
- 4.4 Protecting our rights;
- 4.5 A change in ownership;
- 4.6 Complaints investigation.
